#### C) Role of Institutes:

#### D) Terms & Conditions


- Expenses shall be mutually decided and agreed upon one month in advance during the finalization of the implementation of the any activities.
- 2. The MOU may be amended, renewed and terminated by mutual agreement of the institutions at any time.
- 3. Both the parties can terminate this MOU by 60 days prior written notice to the other party.
- 4. Activities conducted should be mutually beneficial to both the Institutions.

#### E) Confidentiality

- 1. Smt. Hiraben Nanavati Institute of Management and Research for Women, Pune and Baya Karve Women's Study and Research Centre, Pune to hold in confidence all information/ data obtained from either institute or created during the performance of MOU, and will not disclose the same to any third party.
- 2. The above confidential clause under this MOU excludes the information/ data possessed by either institute before entering into this MOU or independently developed information already available through public domain.

#### F) Duration of MOU

This MOU, unless extended by mutual written consent of the institutes, shall expire
after five years after the effective date specified in the opening paragraph, however on
review the MOU shall be extended for another five years by mutual consent.







#### G) Coordinators

Both institutions will designate a person as coordinators for implementation of this agreement.

### H) Intellectual Property Rights

The Intellectual Property Rights (IPR) that arise as a result of joint research and collaboration activity under the agreement will be worked out on a case to case basis and will be consistent with officially laid down IPR policies of both the institutes.
