C) Role of Institutes :

1. The Institute through its experienced faculty members can offer consultancy services in the areas of education and management.
2. The faculty members can conduct Training and Development program as per the need identified by the organizations.
3. Organizing workshops/ seminars/ conferences and Personality Development Program.
4. The Institutes can share required resources to carryout research projects e.g. SPSS, Library IT infrastructure and, the expert faculty members.
5. Encouraging participation of teachers and students in Workshops, Conferences, Sports & Cultural Activities conducted by both the institutions.

D) Terms & Conditions

1. Expenses shall be mutually decided and agreed upon one month in advance during the finalization of the implementation of the any activities.
2. The MOU may be amended, renewed and terminated by mutual agreement of the institutions at any time.
3. Both the parties can terminate this MOU by 60 days prior written notice to the other party.
4. Activities conducted should be mutually beneficial to both the Institutions.

E) Confidentiality

1. **Smt. Hiraben Nanavati Institute of Management and Research for Women, Pune** and **K. B. Joshi Institute of Information Technology, Pune** to hold in confidence all information/ data obtained from either institute or created during the performance of MOU, and will not disclose the same to any third party.
2. The above confidential clause under this MOU excludes the information/ data possessed by either institute before entering into this MOU or independently developed information already available through public domain.

F) Duration of MOU

1. This MOU, unless extended by mutual written consent of the institutes, shall expire after five years after the effective date specified in the opening paragraph, however on review the MOU shall be extended for another five years by mutual

Both institutions will designate a person as coordinators for implementation of this agreement.


H) Intellectual Property Rights
