This MOU is signed between MKSSSS's Smt. HNIMR conducts an MBA course, which is affiliated to Savitribai Phule Pune University. The Institute also undertakes many social endeavors towards the overall development of the students.

In continuation of our discussion and subsequent to your communication we are planning to undertake following activities for the RSGS.

1. Design, development and implementation of assessment and evaluation tools for objective assessments of the different projects of RSGS initially starting with RSGS's Swami Vivekanand Vidyalaya, the school located at village Asade, Tal. Mulshi
 - a. Assessment of the Vidyalaya through these tools for the first time.
2. Designing and Execution of skill enhancement workshops and activities as per the need identification with mutual consent.
3. Design, develop and implementation of various training programmes for the stakeholders associated with RSGS.
4. RSGS will provide HNIMR necessary infrastructure and support to conduct various social activities.

The duration of the MoU between **HNIMR** and **RSGS** is from the year 2022 to 2025 (Three Academic Years). This agreement can be further renewed by the consent of the parties.
