And

GORI STATE TEACHING UNIVERSITY, GEORGIA

The Gori State Teaching University, represented by its Rector, Prof. Giorgi Sosiashvili with the seat at 53, Tchavchavadze str.,1400, Gori and MKSSS's Smt. Hiraben Nanavati Institute of Management and Research For Women, Karvenagar, Pune represented by its. Director, Dr (Mrs).Surya Ramdas, with the seat at Pune Maharashtra, India, state in writing their interest to co-operate and the terms under which they will accomplish activities in order to contribute to the development of their common objectives for mutual benefit. Both parties have agreed on the following articles:

Article 1 - Objective

The objective of this Memorandum of Understanding- is the development of exchange and co-operation activities in the academic, research, scientific and technological areas between the parties.

Article 2 - Activities

Common activities will include:

- 1. Exchange of students, teachers, research and administrative staff in the frame of Erasmus+
- 2. Co-operation in research and science.
- 3. Exchange of academic materials, publications and information.
- 4. Other academic and scientific activities of mutual interest.

Article 3 - Financial Arrangements

Each project or activity of common interest will be funded individually, according to the resources available. The resources necessary for the implementation of common activities can be negotiated by acting coordinators appointed by both parties, respectively.

Article 4 - Agreement on Implementation

Each activity, identified as being of common interest, will be described in an Agreement on implementation, which will include terms and conditions related to the realization, both parties' responsibilities and the academic, scientific, administrative and financial details connected with the implementation, as well as the way of settlement of differing viewpoints or interpretations.

Article 5 - Intellectual Property Rights and Publications

Detailed management of the Intellectual Property Rights and Publications will be defined in the Agreement on Implementation for each agreed activity.

Article 6 - Validity

This Memorandum of Understanding is valid for the period of five (5) years, unless one of the contracting parties notifies the another one in writing its intent to terminate it at least three (3) months prior to the termination date

Amendments to this Memorandum of Understanding can only be in writing after prior consent of both parties.

This Memorandum of Understanding will become effective on the day of its being signed by the representatives of both parties.

This Memorandum of Understanding is signed in two (2) copies in the English language. Each party shall retain one (1) copy.
