

Memorandum of Understanding

This Memorandum of Understanding (hereinafter "MOU") is dated this 15th June 2022.

Between

Samuchit Enviro Tech (Samuchit) having its office at 6, Ekta Park, Law College Road, Pune 411 004 (hereinafter referred as "Samuchit")

And

Mksss's Smt. Hiraben Nanavati Institute for Management And Research For Women (HNIMR) at Karve Nagar, Pune (hereinafter referred as "HNIMR").

Whereas

- A. Samuchit and HNIMR are interested in working together in connection with the Purpose which is described in this MoU.
- B. This MoU sets out the initial relationship between Samuchit and HNIMR as well as the respective rights and responsibilities of the two Parties.
- C. This MoU is not intended to be legally binding but is intended to document the expectations of the two Parties.
- D. Each Party is expected to act in good faith in accordance with this MoU.

(1) PROJECT AND PURPOSE

- (a) The two Parties intend to work together on the project "Carbon Neutral Campus – HNIMR" (hereto referred as "The Project").
- (b) The Project has the following Purpose: **Baseline Carbon Accounting will be carried out for HNIMR premises with an intention to develop and implement a time bound plan for the premises to go carbon neutral.**

(2) GENERAL OBLIGATIONS


- (a) Notwithstanding the non-binding nature of this Memorandum the two Parties will act in good faith and will use their best endeavours to achieve the purpose stated above and to give effect to the terms of this MoU.
- (b) The Parties will each respectively perform all acts and execute all documents as reasonably required in order to give effect to the terms of this MoU.
- (c) Both the Parties agree to co-operate in the spirit of mutual understanding and goodwill in order to develop relationships with one another and in order to pursue the Purpose outlined in the preceding section.

(3) ROLES OF THE ORGANISATIONS

- (a) Samuchit will have the following obligations in relation to the Project.

(1) Provide training to HNIMR faculty and a group of students on the basic principles and processes for carbon accounting.

(2) Provide data collection templates customised to the requirements of HNIMR.

(3) Provide guidance during data collection.

(4) Submit a baseline carbon accounting report in pdf form.

(5) Include in the report a set of recommendations for carbon neutrality for HNIMR based on the baseline carbon accounting.

(b) HNIMR will have the following obligations in relation to the Project.

(1) Create a Carbon Accounting Committee comprising of students and Faculty members of HNIMR .

(2) Collect the data required for baseline carbon accounting as per the datasheets provided by Samuchit.

(3) Consult Samuchit experts from time to time to ensure that the work progresses smoothly and completely with minimal errors and data gaps.

(4) Provide additional information required (if any) by Samuchit to enable Samuchit to provide a comprehensive baseline carbon accounting report and realistic recommendations for taking the HNIMR premises towards carbon neutrality.

(4) TIMING AND DURATION OF PROJECT:

(a) This MoU will commence on 15 June 2022.

(b) This MoU will remain in effect for 12 months during which the Project will be completed.

(c) The two Parties may terminate or extend this MoU by mutual agreement as and when deemed necessary.

(d) The two Parties may amend this MoU by mutual agreement if deemed necessary. The amendments also must be in writing and signed by authorized representatives of both Parties.
